Thank you all very much for your enthusiasm and support as we move forward. I understand that this bill has created quite the buzz in the student leadership community. As we continue to speak with our counselors and refine our approach to this, we ask that you join our efforts to kill the bill in the committee.

We are approaching this issue with caution and a great deal of organization. Of course, everyone is welcome to lobby privately. However, we are coordinating the formal testimony to assure that we stay on message. We see this as an opportunity to demonstrate the maturity and sophistication of the student voice. 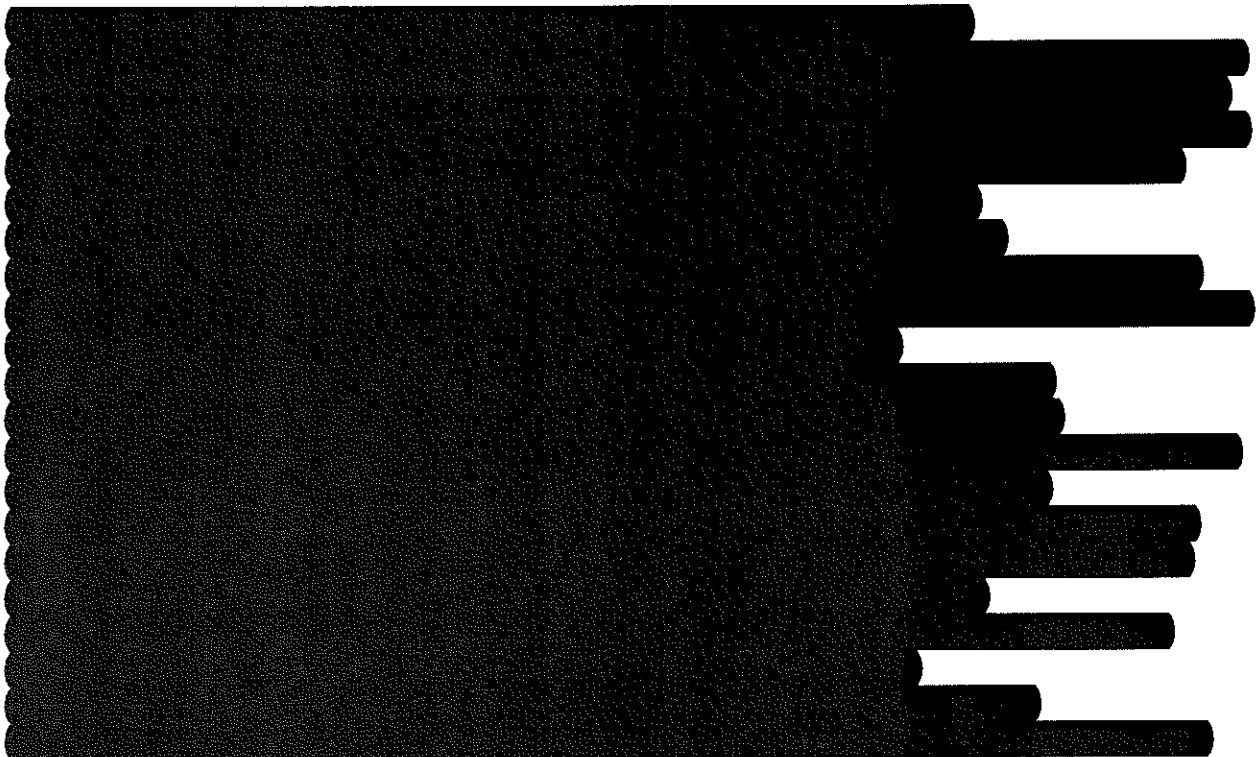

Thank you for your reply. I'm sure you've had a lot on your plate lately. I myself have been battling some form of the upper respiratory virus that must have been spawned from the devil himself! It's been a really rough week or two trying to get well!

I have attended the MASC Legislative Session twice before, but it's been several years since. I think the last time I went was when Emma Graybill was a freshman. She was the only high school student on the bus with us

and I served as her advisor that day. It was a fairly organized event then and the major thrust of the day was listening to various pieces of legislation that the state would be voting on and then of course, determining the State Student Member of the Board recommendation. When I attended before it was once in Prince George's County and once in Prince Frederick County. It sounds as though the event has changed over the years. Since I am not available to attend myself this year, then perhaps this is not something I will encourage my students to attend then, based on what you are telling me.

Wow! The "Legal limit" for the buses is 65?? That is just unbelievable! It must be for small children. Not that I'm doubting you, but it certainly cannot include adults and high school aged students. Wow!! Ok, so however you feel it is best to determine the number of delegates schools can bring ... I know you just want to make sure every school brings a full delegation. And I know there are schools like mine who could bring MORE than our fair share of delegates. I have a lot of kids who really want to attend this trip!

I know in the past advisors used to have to send our numbers in to the Office of Student Leadership by a certain date prior to events. And I know some advisors were delinquent in doing this and it created problems. So, I understand how there is no easy fix to this problem.

There has to be some happy medium with the buses. When one school is brings 30 students plus adults, another 20 students plus adults, and then 2 more schools are assigned to the bus, the math just doesn't work to put all those people on one bus. So, if we tried what you are suggesting, having the advisors work out the details, we would need to know in advance with which schools were going to be assigned so we have time to communicate student numbers.

I suppose it's worth a try! Maybe feeder system buses? I do know that I have more than standard delegation size who would like to attend the trip for Lobbying Day on February 19th. I do have a parent volunteer who can come on the trip if needed. So, I just need to know how many students I can say yes to.

If I can be of any assistance in trying to find a solution, please let me know. I realize, like I said, there is no easy fix! I'm willing to help.

I will not provide transportation to MASC lobbying day. Since your students are in middle school, I will tell you between the two of us, that I do not recommend this event. I'm not sure if you have ever participated but it is significantly less structured than our event. Students wander unsupervised during an open period of time between dinner, the leg buildings, and around town. At some point they kids all assemble in an office room and go over to watch a bit of session, then they leave when they are bored or their rides show up. This is ok for older kids but maybe less structured than I would like for younger kids.

If enough student are interested, I can organize something a bit more structured for our kids on that night. So we can meet up with MASC but have a bit more direction for the rest of the evening. The arundle advisors also expressed interest in this event so I have copied them.

I have not figured out the numbers for lobbying day yet. (again this issue applied to AHS) I really hate to limit participation but the bus situation may force me to cap the numbers. I am thinking that the best way to manage this is to work with the advisors of the other schools who will be riding your bus and decide amongst yourselves how to use the bus space. Believe it or not, the legal limit for school buses in 65!!! Until that number is hit, the transportation department doesn't add another bus. HOWEVER, I am working on it. Hi Aimee,

Happy New Year! I hope this finds you well rested after the holidays and winter break. The student leaders at Southern Middle are raring and ready to make a difference! Seriously, I've had several of the students come in last week and today very excited and asking about Lobbying Day and MASC. I truly appreciate their enthusiasm. It becomes motivating for me!

Here's a few things I where we need some clarification and information so we can get things rolling into the new year:

First - CRASC Dues: I know we owe ours. The CRASC website hasn't been updated in a few years and I don't seem to have on hand any information about how much the dues are. We would like to pay our dues, but we just don't know how much to pay. I've mentioned this to the CRASC Treasurer during the Old Mill General Assembly and asked if he could create a flyer or bill or something. Just a thought.

Second - MASC Legislation Day on February 8th: I am not available this year, but I have a few students who would like to attend. Will there be a bus from CRASC providing transportation? Do you think we will have a delegation from our county attending? I would like to make arrangements for another teacher/parent/advisor to attend for the few students from my school who are interested if this is a possibility.

Finally - LOBBYING DAY: Attendance & Transportation - How many delegates will our school be allowed to bring to this event?



Hi Team,

It looks like we are going to be getting a serious amount of snow this week. I have every intention of having our meeting Wednesday. If evening activities are canceled by AACPS, my hands will be tied and I will not be able to see you all. However, we will proceed with plans.

I'm sure you all know by now, SB 194 only received 1 vote from the Anne Arundel senate delegation, so the bill will not move forward. While we are thrilled by this outcome, it puts us in the unfortunate position of having nothing to lobby for....

I spoke with Nathan last night and we discussed the game plan. The current game plan is to open with a full presentation of SB 194 and our process of testifying against it. We will use this as our demonstration of effective lobbying techniques. Normally we would move onto our bill at this point but since we don't have any, we will be doing something a little bit differently.

CRASC will not take an official position on bills this year but instead, present both side to the discussion of the **Maryland Minimum Wage Act**. Students will then be allowed to take their own position on the bill and lobby privately. The goal of this is to get students to be interested and engaged in the legislative process and to learn a bit more about appropriate lobbying techniques.
